

Resolution Supporting Election Integrity

WHEREAS, the Wyoming Republican Party supports fair and honest elections and supports determining election outcomes by counting accurately the legitimately cast votes of registered United States citizens meeting the State of Wyoming' s voter registration requirements;

WHEREAS, the reliability and accuracy of electronic voting machines have been called into question;

BE IT RESOLVED that the Wyoming Legislature eliminate the use of all electronic voting machines in the state and return to hand-counted paper ballot systems, including absentee and military, for determining the outcome of all elections.

Resolution to Oppose Ranked Choice Voting

WHEREAS, Traditional American primary and general elections ensure that voters who support one candidate, not a plurality of candidates, are heard clearly while ranked choice voting schemes open elections to 'ballot exhaustion' or the disenfranchisement of voters who choose not to support multiple candidates who do not clearly represent their values;

WHEREAS, States and communities where ranked choice voting has been tested have consistently decreased voter participation in those communities and in many cases the elections have resulted in more discarded votes than counted votes;

WHEREAS, Ranked choice voting often results in additional tabulation delays resulting in days or weeks of additional counting while depending exclusively on technology without traceable ballots to support determined winners;

BE IT RESOLVED, the Wyoming Republican Party rejects ranked choice voting and similar schemes

Resolution to Maintain Excellence in American Elections

WHEREAS, The Wyoming Republican Party encourages the broadest possible participation to all registered voters;

WHEREAS, Ensuring the integrity of our voting and election administration is critical and foundational to maintaining a civil and decent society decentralized from a federal government as the Founders intended;

WHEREAS, Americans expect accurate and swift determinations as it pertains to administration of elections and election results;

WHEREAS, elections have been under assault in an attempt to implement schemes and intentionally inject chaotic administrative changes that have drastically changed how elections are conducted in several of the most populous counties across the nation;

WHEREAS, the Wyoming Republican Party supports only properly registered United States citizens voting in our elections;

BE IT RESOLVED, the Wyoming Republican Party calls for the use of methods to strengthen voter confidence, and to ensure that American elections are fair and open

Resolution on Primacy of United States Flag at All Wyoming Government Buildings and Offices

WHEREAS, the flag of the United States was adopted on June 14, 1777;

WHEREAS, the flag of the United States symbolizes the unique and rich history of the nation including the values of valor, bravery, purity, innocence, vigilance, perseverance, and justice;

WHEREAS, the flag of the State of Wyoming was adopted on January 31, 1917;

WHEREAS, the flag of the State of Wyoming, containing the Great Seal of the State of Wyoming, symbolizes the rich history of the State and her legacy industries;

WHEREAS, the United States Flag Code demands that the flag of the United States always be prominently displayed when near other flags;

BE IT RESOLVED, that it be a matter of policy that only the United States and Wyoming flags are displayed on state property.

Change the Language to Control the Narrative

WHEREAS, the Democrat party and the media have dictated many of the terms and narratives describing political, social and legal issues and generates new terms, etc. on an almost daily basis;

WHEREAS, the Republican party has not taken the initiative to use our preferred terms or narratives describing any political, social or legal issue, except the term "Pro Life";

BE IT RESOLVED that the Wyoming Republican Party generate accurate and appropriate terms and make these widely available on issues on the Wyoming Republican Party website. Be it resolved these three examples be introduced: 1. Use the term organic fuels vs. fossil fuels (coal, oil, gas) 2.
